Search Warrants Lead to Arrests

Lake City Police Department has been investigating two separate residences for illegal drug activity. On January 5, 2010 the Lake City Police Department's TAC Unit served two separate search warrants resulting in arrests at both homes. The Lake City Police Department had received complaints about each home which started the investigations. The Lake City Police Department TAC Unit was able to develop information over the past several months to obtain search warrants for each home.
